The basic control and maneuvering course will be on a flat grassy area. There is plenty of parking, shade, and a covered area for entrants, dog crates, and spectators. The freight haul portion will begin near the maneuvering course and will then utilize various surfaces and walk ways throughout the resort and parking area. There will be a gradual sloping terrain that we follow, and we will end near the maneuvering course. The course will have lots of natural occurring distractions from dogs, humans, blow dryers, and such that you would find at a dog show.

## DRAFT TEST INFORMATION

**IMPORTANT NOTICE:** This test will be using the Draft Test Regulations effective March 1, 2024. We will be offering Novice, Open, Excellent, Veteran, Veteran Excellent, and Team classes. To enter the Excellent Class you must send proof of passing the Open Class. To enter the Team Class you must show proof that the individual dogs have passed the individual classes.

**OTHER BREEDS:** Only Saint Bernards may be entered.

**REGULATIONS:** The draft test is sanctioned by and sponsored by the Working Dog Committee of the Saint Bernard Club of America (SBCA). Entrants are responsible for obtaining and reading the regulations governing SBCA Draft Tests. ENTRIES: The classes available at this test are single dog entries in Novice, Open, Excellent, Veterans, and Veterans Excellent, and team entries in all levels. The entry fee for the Draft Test, including requalification is \$38 for classes. Send entry fees (payable to SBCA), a completed entry form and a copy of your dog's registration to Allison Hall, 2823 182<sup>nd</sup> Ave NE, Redmond, WA. E-mail entries will be accepted with payment via PayPal. When e-mail entries are received, a PayPal invoice will be sent from cascadesaintbernards@gmail.com. After the closing date, all entries that provide an email address will have their entry confirmations sent via email.

ENTRY LIMITATIONS: Entries for the draft tests are limited to a total of 18. All entries will be accepted beginning with postmarks on August 1st, 2024. Entries close at 11:59:00 p.m. on Wednesday, October 9th, 2024, or when the entry limit is filled, an alternate list will be established. In order to provide equal opportunity for all exhibitors, entries will be accepted in

order of postmark or email date. In the event of a date tie, a random drawing will be made. No phone entries will be accepted.

The Minimum test entry is 1.

**RE-QUALIFIERS:** Re-qualifiers will be accepted on a space available basis. Untitled dogs will be given first priority even if their entry is postmarked after that of a titled dog. Entries will close when 18 untitled entries in any of the divisions are received prior to or on the closing date, which ever occurs first. If entries fill, an alternate list will be established. Openings will be filled from the alternate list in postmark/e-mail order. In the event of a tie, a random drawing will be made.

**MISCELLANEOUS:** Bitches in season will be allowed to participate. However, bitches will be judged after ALL other entries have completed the test. Unentered dogs must be kept quiet, on leash, or crated, and away from the designated test area.

No carts will be provided unless special arrangements are made in advance. If you are sharing a cart, please let the Secretary know at check-in. If you need to borrow a cart for the test, contact Neil Hall, test chair well in advance. SBCPS does have some carts we can haul to the National and make available at the beginning of National week.
