WEIGHT PULL SITE DESCRIPTION: The Ranch is in Loveland, CO. It is easily reached from Interstate 25. The Weight Pull will be held on a flat area of the parking lot. The pull surface will be indoor/outdoor carpet. The weight used will be bricks on a wheeled cart with fixed wheels.

WEIGHT PULL INFORMATION

IMPORTANT NOTICE: This test will be using the Weight Pull Regulations dated 1/1/2024. Note: the updated regulations do not split pulls into separate classes for awards. Qualifying pulls toward a leg will be awarded Green Rosette, and Highest Percentage and Highest Weight pulled will receive large rosette. For day-of entries, owner is responsible for knowing which weight pull title their dog is working toward.

OTHER BREEDS: Only Saint Bernards may be entered.

REGULATIONS: These weight pulls are sanctioned by and sponsored by the Working Dog Committee of the Saint Bernard Club of America (SBCA). Entrants are responsible for obtaining and reading the regulations governing SBCA Weight Pulls. This test will be using the Weight Pull Regulations dated 1/1/2024. ENTRIES: The entry fees for the Weight Pulls are \$28 for pre-entries. The day-of entry fee for Weight Pulls is \$30. The entry fee for a puppy 6 months to one year of age is \$10 for any of the Weight Pulls. Per regulations puppies may only pull up to 8X their weight. No puppy under 6 months of age will be allowed to pull. Please send the entry fees (payable to SBCA), a completed entry form for each pull to Neil Hall, 2823 182nd Ave NE, Redmond, WA 98052, or completed entry form electronically to cascadesaintbernards@gmail.com with a request for a PayPal invoice.

ENTRY LIMITATIONS: There are no entry limits. All entries will be accepted beginning with postmarks on August 1st, 2024. **Pre Entries close at 11:59 p.m. on Wednesday, October 9th, 2024.** Email entries will be accepted with payment by PayPal. A PayPal invoice will be sent from cascadesaintbernards@gmail.com. No phone entries will be accepted. Day-of entries will be accepted until 30 minutes before the start of the weight pull.

MISCELLANEOUS: Bitches in season will be allowed to participate. Please place some sort of barrier (bitch pants) on the girl to prevent drippage on the carpet. Unentered dogs must be kept quiet, on leash, or crated, and away from the designated pull area.
